## A.Rules and Regulations governing the election of the Fellows of ISEB

The election of Fellows will be governed by the rules and regulations framed by the ISEB.

- 1. The candidates elected as Fellow of ISEB can write FISEB after their names.
- 2. The number of Fellows elected by the Society shall be limited to ten annually. The fellowship will be awarded to the scientists who have made significant research contribution in the field of Environmental Science, including those who have contributed significantly towards the mitigation of environmental problems.
- 3. Up to two distinguished scientists who have done outstanding research in Environmental Science will be recommended by the Executive Committee for the award of Honorary Fellowship of ISEB.
- 4. Each candidate will be nominated and seconded by Fellows of ISEB on a nomination form prescribed for the purpose. A Fellow may nominate up to two candidates each year for election to the ISEB Fellowship. The Fellow of ISEB, who proposes the nomination, will certify from his/her personal knowledge of the nominee's scientific achievements. The nomination made for the Fellowship will remain in good standing for a period of 5 years. If the nominee is not elected during this period, he/she may be re-nominated after a gap of 2 years.
- 5. Any nominee who can vasses for support for his election to the Fellowship shall be disqualified for election as the Fellow of ISEB.
- 6. The last date for submitting nomination papers shall be announced through advertisement every year, and the decision about the election to the Fellowship will be taken within 2 months, by the end of submission of nomination papers, on the recommendation of the Fellowship Committee, constituted for the purpose by the President ISEB.
- 7. The Fellowship Committee shall recommend not more than 10 candidates for election to the Fellowship of ISEB. The list of recommended candidates will be submitted to the Convener Fellowship Affairs ISEB, in a sealed cover. The Convener Fellowship Affairs ISEB will place the list in the meeting of the Executive Council(EC) of ISEB. The EC will further scrutinize the recommendations of the Fellowship Committee and shall have the power to delete any name from the list, but it cannot add any new name, and approve names of selected candidates for ISEB Fellowship.

<u>Cessation of Fellowship</u>: Any Fellow may withdraw from the Society by giving reason to do so, by a letter addressed to the President ISEB. The letter of withdrawal may be cancelled, at the request

of the sender, within six months of its receipt by the Secretary. If any Fellow of the Society willfully disobeys Rules or Orders of the Society, or commits willful breach of order at any of the Meetings, or persists in any disobedience or breach of order, after having been admonished by the President, or indulges in any such activity which brings dishonor to ISEB, he/she shall cease to be a Fellow and shall be liable to be removed from the Society.

# B. Rules and Regulations governing the Award of ISEB Young Scientist Medal

ISEB has decided to recognize the significant contribution made by young scientists in the field of Environmental and allied Sciences by awarding them ISEB Young Scientist Medal (ISEB-YSM). The ISEB-YSM will be awarded annually.

- 1. The nominees for the medal should hold a Ph.D. degree and should not be more than 35 years of age at the time of submitting the nomination papers.
- 2. There would be a maximum of three awards every year.
- 3. Each candidate will be nominated and seconded by Fellows of ISEB on a nomination form prescribed for the purpose. A Fellow may nominate up to two candidates each year for election to the ISEB Young Scientist Medal. The Fellow of ISEB, who proposes the nomination of a candidate, will certify from his/her personal knowledge of the nominee's scientific achievements. The nomination will be seconded by another Fellow of ISEB.
- 4. The last date for submitting nomination papers shall be announced through advertisement every year, and the decision about the election to the Fellowship will be taken within 2 months, by the end of submission of nomination papers, on the recommendation of the Fellowship Committee, constituted for the purpose by the President ISEB.
- 5. The Award Committee shall recommend not more than three candidates for election to the ISEB-YSM. The list of recommended candidates will be submitted to the Convener Fellowship Affairs,ISEB, in a sealed cover. The Convener Fellowship Affairs ISEB will place the list in the meeting of the Executive Council of ISEB. The E.C. will further scrutinize the recommendations of the Fellowship Committee and shall have the power to delete any name from the list, but it cannot add any new name, and approve names of the selected candidate for ISEB Young Scientist Medal.
